- I understand and agree that in admitting my dog, the SPCA(HK) has relied on my representation that my dog is in good health. I agree to inform the SPCA(HK) prior to the commencement of each class if my dog is ill, or has received recent veterinary attention at the SPCA(HK) or at a private clinic, and can provide the medical details if required. I further understand that participation in the course is at the discretion of the veterinary surgeon or trainer in charge of the course.
- I understand that attendance of the course is not without risk to myself, members of my family or guests who may attend, or to my dog, because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care. I hereby agree to indemnify and hold harmless the SPCA(HK), its employees and agents from any and all claims by any member of my family or any other person accompanying me to any training session or function of the SPCA(HK) or while on the grounds or the surrounding area thereto as a result of any action by any dog, including my own.
- I understand and agree that any problem that develops with my dog will be treated as deemed best by staff of the SPCA(HK), and that I assume full financial responsibility for any all expenses involved.
- I understand and agree that refund will be provided only for the class cancellation made by SPCA(HK) and the cheque will be sent within 4 weeks and SPCA(HK) only accept any changes made by 14 days notice prior to the first lesson. \$100 will be charged as a handling fee for every lesson.
