SPCA Jockey Club Centennial Centre (Tsing Yi Centre) Rooftop Pet Garden - Rules and Regulations

Only active members can bring their own dogs to enter the Rooftop Pet Garden located at the rooftop of the SPCA Jockey Club Centennial Centre (Tsing Yi Centre). By bringing your dog(s) to the Rooftop Pet Garden, you are deemed to have read, understood and agreed to the following Terms and Conditions.

- 1. The Rooftop Pet Garden is open from Tuesdays to Sundays 10:00 17:00, last admission is at 16:30; Closed on Mondays.
- Members need to register and pay a cash deposit of HK\$100 at the G/F reception to get an access card to the Rooftop Pet Garden, which is valid for 2 hours. If the access card is lost, damaged, or returned late, the deposit will not be refunded.
- 3. Only domesticated pet dogs are permitted to enter the Rooftop Pet Garden.
- 4. "Fighting dogs", or other "known dangerous dogs" as classified under the Dangerous Dogs Regulation (Cap 167D) should not enter the Rooftop Pet Garden.
- 5. Dog(s) should not be left unattended under any circumstances.
- 6. Each member's account is allowed to bring a maximum of 3 people and no more than 2 dogs to the Rooftop Pet Garden.
- 7. Dogs should be inoculated against rabies, and be fully vaccinated against common infectious diseases.
- 8. Dog(s) are permitted to be walked on the Rooftop Pet Garden but should AT ALL TIMES remain on a leash, be under proper control, and be effectively restrained from causing nuisance or danger to others.
- 9. Members/owners are required to keep the rooftop clean and hygienic; they should immediately clean up any faeces or urine, and provide their own sealed bags, containers and/or tools for proper waste disposal.
- 10. Members/owners shall be solely responsible for any injuries to their dog(s) and/or injuries to other dogs/people while at the Rooftop Pet Garden. In additional they shall be solely responsible for damage to and/or loss of property and/or belongings of other dogs/persons or SPCA property. For the avoidance of doubt, the SPCA shall not be responsible and does not assume any liability for any such injuries, damage to and/or loss, whether such injuries, damage and/or loss is caused by the SPCA or otherwise.
- 11. If members/owners are found to be in breach of any of these Terms and Conditions and/or if the SPCA at its sole discretion determines that the behaviour of the dog(s) is a threat to and/or a disturbance to others, the SPCA shall have the right to deny entry to or request members/owners and their dog(s) to leave the Rooftop Pet Garden immediately.
- 12. Members/owners shall observe and comply with all directions and measures given from time to time by the SPCA concerning social distancing, crowd control and management of the Rooftop Pet Garden.
- 13. The SPCA has the right to interpret these Terms and Conditions. In case of disputes, the decision of the SPCA will be final and binding on all parties concerned.
- 14. The Chinese version of these Terms and Conditions is for reference only. In case of discrepancies between the provisions of the English version and the Chinese version, the English version shall prevail.
- 15. These Terms and Conditions shall be governed by the laws of Hong Kong Special Administrative Region.
